1. CALL TO ORDER

Councillor Karsten, Chair called the meeting to order at 9:30 a.m. in the Council Chamber, 3rd Floor City Hall, 1841 Argyle Street, Halifax.

3. CHIEF ADMINISTRATIVE OFFICE

The following was before Council:

 A staff recommendation report dated January 2, 2018 with attached CAO Business Unit 2018/19 Multi-year Budget and Business Plan presentation

Jacque Dubé, Chief Administrative Officer (CAO) provided introductory remarks and presented the draft 2018-2019 Multi-year CAO Business Unit Budget and Business Plan. The CAO suggested increasing the out of town travel budget for the Councillor Support office by \$30,000, to address increased demands for engagement at events such as: Federation of Canadian Municipalities Board meetings, Union of Nova Scotia Municipalities related activity, speaking engagements and various conferences.
