AMENDMENT: Motion approved that Attachment B be amended to include include the word "temporary" in reference to "asphalt plant" in sections 1, 3, and 4 of the LUB and replace section 18.8 with the following:

"(a) Notwithstanding Section 18.2, a temporary asphalt plant shall be permitted on lands shown on Schedule S provided that:

i. all vehicular access and egress to and from the temporary asphalt plant site shall be from the Ingramport Interchange; and

ii. the plant uses a dry-system method whereby no effluent or water-based by products are directed to the ground.

(b) A development permit issued for the use of a temporary asphalt plant shall be valid for any period specified not exceeding sixty (60) days per calendar year except that a development permit issued under this clause may be renewed for a period not to exceed thirty (30) days, if a development officer determines that an extension of the period is necessary to allow the completion of work in progress."
