First Reading was given on February 8, 2022.

Jesse Morton, Planner II, gave a presentation on Case H00519 and responded to questions of clarification from Regional Council.

The hearing opened at 6:24 p.m.

Mayor Savage invited the applicant to come forward and address Council.

Chris Markides, Urban Planner, Zzap Consulting Inc. and Jordan Ghosn, Developer, Grafton Developments Inc., Sterling Inn Limited gave a presentation on Case H00519 and responded to questions of clarification from Regional Council.

Mayor Savage reviewed the rules of procedure for public hearings and called for anyone wishing to speak on the matter.

Shelley Goulding, South End spoke to concerns with the impact on natural light due to the size of the proposed new structure and asked Regional Council to focus on wording of the standards regarding subordination when making their decision.

Mike Fitzmaurice, Halifax spoke to concerns that the restorations to the Waverley Inn would be overshadowed by the proposed new structure and that the proposed new structure would substantially modify the character of the neighbourhood.

Calvin Blades, Bedford spoke to their experience as a long-time employee of the Waverley Inn and shared that the current iteration of the Inn is not financially viable. Blades noted that the opportunity to expand capacity through this application is supported by the Waverley Inn and responded to questions of clarification from Regional Council.

Jane Risley, Halifax spoke to concerns with losing valuable heritage properties by prioritizing large developments, changing regulations, and the need for affordable housing.

Karen Clegg, South End spoke to concerns with the visibility of the proposed breakfast nook, parking availability, and the possibility that the proposed new structure could become a luxury apartment building in the long term.

Mayor Savage called three times for any other members of the public wishing to speak on the matter, there were none present.

Mayor Savage invited the applicant to respond to questions raised by the public.

Markides responded to comments and noted that the Standard outlining subordination states that size is not a consideration, and that the application conforms with related Municipal policies and by-laws.
