Blackwood responded to questions of clarification from Budget Committee regarding the process for considering budget reductions, noting that reductions could be put forward and voted on from the floor of a meeting or referred to the Budget Adjustment List. Blackwood further noted that all potential reductions

or increases would be accompanied by briefing notes for Budget Committee's consideration as attachments to each Business Unit budget presentation report.

O'Toole responded to questions of clarification from Budget Committee regarding Administrative Order 2022-003-ADM, *Respecting Commercial Property Taxation in Certain Areas of the Municipality*, noting that conversations with the Government of Nova Scotia were forthcoming as the implementation of the by-law requires approval by the Minister of Municipal Affairs and Housing.

Renée Towns, Director of Revenue/Treasurer, and Caroline Blair-Smith, Deputy Chief Administrative Officer, Corporate Services, responded to questions of clarification from Budget Committee.
