## **1. CALL TO ORDER AND LAND ACKNOWLEDGEMENT**

The Chair called the meeting to order at 9:31 a.m. and acknowledged that the meeting took place in the traditional and ancestral territory of the Mi'kmaq people, and that we are all treaty people.

## **4. CALL FOR DECLARATION OF CONFLICT OF INTERESTS – NONE**

## **5. PUBLIC PARTICIPATION**

**Melany Nugent-Noble, Downtown Halifax Business Commission**, spoke to their concerns with potential funding reductions to the Professional Arts Grant program, the merits of Nocturne Festival and noted that the elements of arts and culture in Halifax that drew them to the city as an artist.

**David Jones, Dartmouth**, spoke to their concerns with potential funding reduction to the Dartmouth Heritage Museum and Canoe Kayak Atlantic Division, standards for storing heritage artifacts, and highlighted the integral role the Dartmouth Heritage Museum has played in plans and strategies to preserve heritage while addressing colonialism within heritage spaces. Jones responded to questions of clarification from Budget Committee.

**Joanne Pepers, Dartmouth Heritage Museum**, spoke to their concerns with potential funding reductions to the Dartmouth Heritage Museum, the scope of work and programming that the funding agreement with the Halifax Regional Municipality (HRM) enables the Museum to do and noted that the loss of this grant would result in the loss of access to other grants for operational funding. Pepers further encouraged Budget Committee to stop targeting arts and culture funding as a soft target for budget cuts, highlighted the burnout that the arts community faces, and responded to questions of clarification from Budget Committee.

**Anita Price, Halifax**, spoke to their concerns with the potential funding reduction to the Dartmouth Heritage Museum, the importance of the Museum's role in overarching strategies to protect heritage in the HRM, and encouraged Budget Committee to provide adequate budgetary support rather than cutting funding.

**Jon Stone, Dartmouth**, spoke to their concerns with the potential funding reduction to the Dartmouth Heritage Museum, their role within the Helen Creighton Legacy Society and the history of the Society's work, the commitment on behalf of previous Councils to preserve heritage, and the larger cultural implications of erasing heritage.

**Daniel Peters, Dartmouth**, spoke to their concerns with the potential funding reduction to the Dartmouth Heritage Museum, the importance of Evergreen House in the community, and highlighted the importance of cultural activities on community well-being.

**Kortney Dunsby, Ecology Action Centre**, spoke to their concerns with potential funding reductions within the Planning & Development proposed 2023-24 budget impacting community development and highlighted that cutting funding to park acquisition would act in contradiction to overarching strategies within the HRM and result in the loss of one of the HRM's only activities that works to protect natural habitat. Dunsby further expressed their support for increasing building permit fees, noted that these fees had not been increased since 1997, and encouraged Budget Committee to acquire Sandy Lake.

**Michael Craven, Dartmouth**, spoke to their concerns with potential funding reductions to the Dartmouth Heritage Museum consultation leading up to this meeting, summarized decisions made regarding arts funding since 1997 and noted that every dollar in funding from the HRM results in another 80 cents being made available to the Museum from other funding sources.

**Cindy Campbell-Stone, Dartmouth**, spoke to their concerns with potential funding reductions to the Dartmouth Heritage Museum, highlighted the cultural and historical significance of Dr. Helen Creighton in the community, and encouraged Budget Committee to invest in the Museum.

**Ceo Gaudet, Dartmouth**, spoke to their concerns with potential funding reductions to the Dartmouth Heritage Museum, the overwhelming impact that the proposed cut would have on the Museum while making only a small impact on the HRM's overall budget, and encouraged Budget Committee to invest in the Museum instead of considering cutting funding.

**Mark James, Atlantic Division CanoeKayak Canada**, spoke to their concerns with potential funding reductions to Lake Banook racecourse, the positive community impact of programming at Lake Banook, the role that Lake Banook has played in legitimizing canoeing and paddling that extends far beyond the HRM, and responded to questions of clarification from Budget Committee.

**Peter Courtney, Atlantic Division CanoeKayak Canada**, spoke to their concerns with potential funding reductions to Lake Banook racecourse, the scope of the programming and community impact at Lake Banook, the economic impact of events like Canoe '22.

**Darcie Bernhardt, Distict 8**, spoke to their opposition to any potential funding reductions to the professional arts, funding for accessibility, and cultural funding at large. Bernhardt stressed the importance of the arts as a means for supporting and preserving Indigenous history and culture, the importance of professional arts funding and spaces as an Indigenous artist, and the arts as a cultural healing space. Bernhardt encouraged Budget Committee to consider the impact of cutting arts funding on the livelihood of community members.

**Carmel Farahbakhsh, District 7**, spoke to their opposition to any potential funding reductions to professional arts funding, the Discovery Centre, green spaces, and proposed increases to fees for key services. Farahbakhsh highlighted that arts and culture, accessibility, and community safety are 3 pillars

of community well-being, cited studies that highlight the socioeconomic importance of arts and culture, and shared their concerns with lack of sustainable funding for the arts.

**Sebastian Labelle, District 5**, spoke to their role at the Bus Stop Theatre on Gottingen Street, the scope of programming, community support, and high frequency of events that the Theatre puts on throughout the year, and the importance of arts and culture spaces and festivals throughout the pandemic. Labelle noted their opposition to potential funding reductions to the Professional Arts Grants program, detailed the loss of community theatre spaces in the HRM since 2018, highlighted the importance of all three levels of government investing in the arts while noting that current levels of government funding do not demonstrate the arts as a priority. Labelle responded to questions of clarification from Budget Committee.

**Susanne Chui, District 8**, spoke to their opposition to potential funding reductions to Professional Arts Grants program, outlined the impact this funding has had on Mocean Dance Studio, and noted that recommendations previously put forward to increase the per capita funding for the arts have not been implemented as current per capita funding in HRM is \$1.16 while other major cities are around \$7.00. Chui noted that the Professional Arts Grants program supported the work of 36 organizations last year and encouraged Budget Committee to invest in the arts rather than considering cuts. Chui responded to questions of clarification from Budget Committee

**Stephanie Domet, District 8**, spoke to their opposition to potential funding reductions to the Professional Arts Grants program, and that the proposed cut spurred conversations between several organizations and festivals in the HRM about the economic impact arts and culture spaces have on the HRM. Domet highlighted that the benefits of funding for the arts are far-reaching and encouraged Budget Committee to invest in the arts rather than considering cuts.

**Wren Tian, District 8**, spoke to their opposition to potential funding reductions to the Professional Arts Grants program and cuts that impact accessibility. Tian spoke to their work at the Eyelevel Gallery, the importance of arts and culture as safe spaces for the BIPOC community and encouraged Budget Committee to reflect on how priorities are demonstrated by what is being funded and what is being considered for cuts.

**Raven Davis, Halifax**, spoke to their extensive involvement in the arts and culture community in the HRM and throughout the province, their opposition to proposed cuts to the Professional Arts Grants program, and encouraged Budget Committee to invest in the arts rather than considering cuts.

**Colin May, Dartmouth**, spoke to understanding the importance of the arts, and suggested that Budget Committee consider hedging fuel costs.

**Kate MacDonald, Halifax**, spoke to their opposition to potential funding reductions to the Professional Arts Grants program, the importance of the arts in their involvement in community as a life-long resident of the HRM, and encouraged Budget Committee to think about the kind of future being funded when increases to the Halifax Regional Police (HRP) is being considered when there are more than 800 houseless people in the HRM.

**Lou Campbell, District 8**, spoke to their opposition to potential funding reductions to the Professional Arts Grants program and feeling disheartened that the proposed cuts add up to an amount less than the requested increases to the HRP budget.

**Viv, District 8** spoke to their concerns as a healthcare worker with the potential funding reductions to arts and culture programming, reduction of snow clearing for seniors, and libraries and the impact that these cuts will have people's ability to participate in recreational activities. Viv stated their opposition to the increased HRP budget, the importance of accessible and high-quality transportation, that cutting arts funding is a means of decreasing the socioeconomic well-being. Importance of funding and responded to questions of clarification from Budget Committee.

**Meredith Caliman, Halifax**, spoke to how funding decisions in other jurisdictions and the effect they had on funding to the arts community at large. Caliman highlighted their involvement in the arts since moving to Nova Scotia, the importance of the arts within the HRM and encouraged Budget Committee to invest in the arts rather than considering cuts.

**Jean Saratoke, Halifax** spoke to the affect that the arts and culture community has on their experience as an individual who moved to Halifax as an international student and encouraged Budget Committee to consider what happens to people with stories like theirs when funding to the arts is cut.

**Saba Blyden-Taylor, District 7**, spoke to their experience as a staff member at the Khyber Arts Centre and the role that the arts has had on their well-being, and asked that Budget Committee to consider what could happen to community-wellbeing when the funding to the arts is cut.

**Heather Wilkinson, District 8** spoke to their opposition to potential funding reductions to the Professional Arts Grants program, their involvement in the arts and culture community in the HRM, the scope of the programming at Wonderneath Arts Society, highlighted the essential nature of the Professional Arts Grants program to many of these organizations' existence, and invited the HRM to be an active partner in continuing to develop a vibrant arts sector.

**Collins Ellison, District 8**, spoke to their support for increasing funding to address homelessness and poverty in the HRM, their opposition to increased funding for the Halifax Regional Police, and highlighted the economic impact of incarcerating unhoused individuals rather than providing them with supports to be housed. Ellison spoke to their concerns with scope of the proposal for a day-time warming center, and noted that stopgap measures in place now will not address homelessness.

**Lara Lewis, District 7**, spoke to their opposition to potential funding reductions to the Professional Arts Grants program and their involvement in the arts and culture community in the HRM as Chair of the Bus Stop Theatre Board. Lewis noted the importance of being able to live and work in this space as an Indigenous artist, and their concerns with the narrative that if you are an artist that you need to go elsewhere to thrive.

**Sally Wolchyn-Raab, District 8**, spoke to their opposition to potential funding reductions to the Professional Arts Grants program, the power of the arts for individuals and economic impact of the arts, and programming at the Eyelevel Art Gallery. Wolchyn-Raab highlighted the impact of the funding that Eyelevel receives from HRM and the money that turns back into the economy, and that folks in the arts are tired of being asked to participate on committees and boards only to have their advice ignored.

**Sam Penner, District 10** spoke to their opposition to potential funding reductions to the Professional Arts Grants program, public library funding, senior snow removal, and concerns with the lack of opportunities for individual artists to apply for funding. Penner encouraged Budget Committee follow the recommendation to create an arms-length organization to fund arts programs, to consider increasing funding for the arts, and to keep this level of turn out in mind when considering budgets in the future.

**Sara Coffin, District 8** spoke to their opposition to potential funding reductions to the Professional Arts Grants program, their involvement in Mocean Dance, and the importance of working together to improve the vitality of the city. Coffin spoke to concerns with 60% of funding for bonus zoning going into to housing and that of the other 40%, none of it goes into the arts.

**Susan LeBlanc, District 5**, spoke to their involvement in the arts community in the HRM, detailed decisions made by other levels of government that have contributed to difficulties for the arts community, and noted that when funding has devolved from other levels of government the HRM has stepped up. LeBlanc encouraged Budget Committee to continue stepping up, and to invest more money in art, artists, art spaces.

Mayor Savage spoke to the importance of the public participation during the Municipal Budget process.
