#### **5. PUBLIC PARTICIPATION**

**Kortney Dunsby, Ecology Action Centre** spoke to the Regional Plan, the demand for housing development in Halifax Regional Municipality (HRM) and noted that adequate resources must be allocated to the Integrated Mobility Plan, Halifax Green Network Plan, Suburban Plan and Rapid Transit Corridors. Dunsby encouraged Budget Committee to fully fund the JustFOOD – Action Plan for the Halifax Region and the Culture and Heritage Priorities Plan in the 2024/25 Municipal Budget. They noted the importance of community building, infrastructure and quality of life considerations as HRM continues to grow at a rapid pace and that growth be undertaken sustainably and with proper considerations for the environment. Dunsby expressed disappointment that the delivery of the Green Network Plan is missing from the 2024/25 Planned Work Highlights in the staff presentation dated February 13, 2024. Dunsby spoke to the Ecology Action Centre's dissatisfaction with the Province of Nova Scotia's recent policy decisions regarding coastal protection, the Building Code and wetland protections.

Jacqueline Hamilton, Executive Director, Planning & Development gave a presentation and responded to questions of clarification from Budget Committee.

Hamilton, Harley, Green and Duncan spoke to HRM's progress with the Housing Accelerator Fund (HAF), the Strategic Priorities Plan 2021-15, HRM's work with African Nova Scotian communities and community engagement initiatives as they relate to the Regional Plan.

Mayor Savage resumed the Chair.

Jerry Blackwood, Executive Director of Finance & Asset Management/Chief Financial Officer responded to questions of clarification regarding the processing of Building & Development Permits, the HAF and infrastructure concerns that are expected to be addressed by the upcoming Capital Plan.

Mayor Savage stepped down from the Chair and Deputy Mayor Deagle Gammon assumed the Chair.

Greene and Hamilton responded to questions of clarification regarding affordable housing and staffing as it relates to the HAF, plans to update the Housing Needs Assessment and the Trusted Partnership Program.

Cathie O'Toole, Chief Administrative Officer (CAO) spoke to the HAF and suggested the topic come before Regional Council at a future meeting. O'Toole noted plans for the CAO's office to distribute a memo outlining timelines, upcoming reports and the negotiation process as it relates to the HAF.
