- 10.3.1 Pam Williams and Tony Smith re: Council of Parties for the Restorative Inquiry into the NS Home of Colored Children

- A report produced by the Council of Parties of the Nova Scotia Home for Colored Children Restorative Inquiry entitled: "Council of Parties Report – Winter 2016/17"

Mr. Tony Smith and Chief Justice Pam Williams provided a presentation to members of the Standing Committee regarding the Restorative Inquiry (RI) into the Nova Scotia Home of Colored Children. They underscored that the RI is focused on building strong relationships with all partners and using the process as a lens on broader issues of systemic racism and its effects. They noted that engaging and mobilizing youth is a crucial aspect of the process of developing knowledge and understanding leading to social change. The presenters indicated that the next steps in the RI are sharing circles with former residents, partner circles, further research, and moving forward to address key issues.

Mayor Savage thanked the presenters for sharing their information. He commented that Nova Scotia is becoming well known for restorative justice, and he was pleased to see this example of such a process working to recognize systemic racism and learn from past mistakes to develop a basis for making real change.

The presenters responded to questions of clarification. Chief Justice Williams expressed how important it is to learn about how racism has created trauma in African Nova Scotian communities before moving forward to make improvements. She advised that although it is beyond the scope of the RI to address hundreds of years of systemic racism in such a short amount of time, she is hopeful that some key issues will be addressed, and moreover a roadmap will be developed so that others can build off the work to tackle issues the inquiry not able to address.

Mr. Smith commented on his experiences through the RI process. He noted that many former residents credit the Home for helping them realize better lives, and although some abused their authority there are positive accounts as well. He indicated that a crucial element of the RI has been the creation of safe spaces so that people feel comfortable sharing their experiences without fear of being attacked.

Mayor Savage noted that the municipality would be honored to be included in the process where appropriate, and he invited the presenters to return to the Standing Committee in the future with further updates. He concluded with a quote from author Lewis B. Smedes:

"Forgiving does not erase the bitter past. A healed memory is not a deleted memory. Instead, forgiving what we cannot forget creates a new way to remember. We change the memory of our past into a hope for our future."

The Standing Committee recessed at 10:48 a.m. and reconvened at 10:52 a.m.
