#### 12.2.1 Follow-up Review: Reports Released from March 2014 – January 2016

Evangeline Coleman-Sadd, Auditor General and Paul Flinn, Audit Director, provided a presentation on their follow up review of reports released from March 2014 to January 2016. The outcome of the review noted by the Auditor General was that, of the nine reports released between March 2014 and January 2016, 54% (14 of 26) of significant issues are outstanding two to four years later; and of the nine reports, three had minimal or no work done to address identified risks. The Auditor General concluded the presentation advising that management needs to take action to correct known deficiencies, and

suggested that this Committee could help by requesting management speak to the Committee on how they plan to address know issues and ask for action plans with a timeline.

The Auditor General responded to questions.

- 2. Authorize the withdrawal of \$50,000 from the General Contingency Reserve to fund the two (2) capital grants, \$25,000 for a grant to the Sac-A-Wa Canoe Club and the \$25,000 for a grant to the Sheet Harbour and Area Chamber of Commerce, as approved under the 2017 Community Grants Program, to be incurred in 2018-19, subject to confirmation of the required Federal government funding and a demonstrated ability to proceed with construction.
