# 12.1 STAFF

#### 12.1.1 Extended Producer Responsibility (EPR) – Staff Presentation

The following was before the Standing Committee:

A staff presentation titled "Extended Producer Responsibility"

Laurie Lewis, Program Manager, Policy & Outreach, provided the Standing Committee with a presentation on Extended Producer Responsibility ("EPR"). The presentation covered the benefits of EPR, the different models practiced in other jurisdictions, and the current state of EPR in Nova Scotia.

Responding to questions of clarification, Laurie Lewis and Matthew Keliher, Manager, Solid Waste, noted the following:

- The main difference between Nova Scotia and other jurisdictions that practice EPR is who is paying for the recycling program. Under EPR, it is not the tax payer, but the producer or manufacturer.
- Only the provincial government has the jurisdiction to implement EPR in Nova Scotia.
- It is projected that the Municipality would save millions if EPR was implemented in the Province, depending on the model used.

The Chair thanked Laurie Lewis and Matthew Keliher for the presentation.

# 12.1.2 Federal Funding Opportunity: Low Carbon Economy Challenge

  - Scotia Bank Centre Waste Heat Recovery
  - Dartmouth Sportsplex Cogen Plant
  - Pool Filtration System Upgrades
  - Landfill Gas Utilization at Otter Lake Landfill
  - Halifax Organics Management and Long-Term Operating Contract RFP
  - Cogswell District Energy System
- 2. That the Environment and Sustainability Standing Committee's recommendation and the staff report dated April 6, 2018, be forwarded to Regional Council for consideration at its meeting held on May 8, 2018.

Responding to questions of clarification, Shannon Miedema, Manager, Environment & Energy, noted the following:

- There is no limit on the number of proposals the Municipal can put forward under the program. There is a competitive selection process, however, with green house gas reduction per dollar of federal funding being the main selection criteria.
- Transportation projects are excluded from consideration for funding under this initiative.
- The project listed in the report are the ones that staff felt would be the most competitive given the criteria of the initiative.

# 13.1 Councillor Mancini - Plastic Straw Reduction Strategy

The following was before the Standing Committee:

A request for the Environment and Sustainability Standing Committee's Consideration form.

MOVED by Councillor Mancini, seconded by Councillor Karsten

# THAT the Environment and Sustainability Standing Committee request a staff report on a Plastic Straw Reduction Strategy in consultation with the Restaurant Association of Nova Scotia (RANS).

Councillor Mancini spoke to the Standing Committee about the negative impacts of plastic waste on the environment, noting that plastic straws are a significant contributor to this issue. They noted that there are many alternatives to plastic straws and a reduction strategy would be an effective step for the Municipality to take in reducing plastic waste.

Mancini further noted that in developing a Plastic Straw Reduction Strategy, the Municipality needs to work with the private sector as well as take consideration of the needs of individuals who use straws for health reasons.

Zurawski rejoined the meeting at 2:00 p.m.

Councillor Nicoll requested that the report also include an educational piece on the environmental impact and harms of plastic straw waste.

Councillor Karsten proposed the following amendment:

# THAT the motion be amended so that in addition to the Restaurant Association of Nova Scotia (RANS), the staff report on a Plastic Straw Reduction Strategy <u>also be completed in consultation</u> with regional head offices of major fast food chains operating within the Municipality.

The amendment was considered by the Standing Committee as friendly.

#### 13.2 Councillor Blackburn - Air Conditioner Disposal at Household Hazardous Waste Depots

The following was before the Standing Committee:

• A request for the Environment and Sustainability Standing Committee's Consideration form.

MOVED by Councillor Blackburn, seconded by Councillor Cleary

# THAT the Environment and Sustainability Standing Committee request a staff report on permitting portable air conditioners to be disposed of/collected at Household Hazardous Waste Depots without prior removal of the CFCs (refrigerant gases).

Speaking to the motion, Councillor Blackburn explained that the Municipality currently provides curbside services to remove refrigerant gases ("CFCs") from household appliances, such as refrigerators and air conditioners, at residential properties prior to their disposal. These services do not currently extend to non-residential properties and residential properties with more than six (6) units. The motion would allow for portable air conditions to be dropped off at Household Hazardous Waste Depots throughout the Municipality where the CFCs would be removed.

Councillor Zurawski requested that the report include the following:

- Clarification on whether the manufacturer would be required to cover the cost of removing the CFCs on portable air conditioners;
- An examination on whether there are other household appliances that could be included; and
- An estimation of the cost to the Municipality.

# **17. PUBLIC PARTICIPATION**

The Chair invited members of the public wishing to address the Environment and Sustainability Standing Committee to come forward.

John Cascadden, Chair of Halifax Waste Resources Society, Louis Lake, spoke to the Standing Committee about the benefits of EPR for the Province. They noted that EPR will not move forward in Nova Scotia without Municipalities getting on board first. They encouraged Councillors to talk to MLAs to promote EPR.

**Paul Arnold, Dartmouth,** provided the Standing Committee with a handout titled "Petition to Consider WSF Organics Pilot Study at Otter Lake." They spoke to the Standing Committee about utilizing the current Waste Stabilization Facility at Otter Lake to meet the Municipality's needs relating to manage and process organic waste. They requested that the Municipality allow a pilot study on the capacity of the facility to manage organic waste to proceed prior to any release of a Request for Proposals for organics management.

Councillor Mancini called three (3) times for any further members of the public wanting to address the Environment and Sustainability Standing Committee. There were no additional speakers.
