10.3 Presentation

10.3.1 Bruce Clarke, Q.C. Buchells LLP, on behalf of the Transportation Association of Nova Scotia re: Vehicle Sideguard Protection required by HRM

Bruce Clarke, Q.C. provided a presentation on behalf of the Transportation Association of Nova Scotia respecting Vehicle Sideguard Protection for contractor vehicles required by HRM. Clarke displayed visual representations of large commercial trucks which require sideguard protection and expressed concerns from the membership of the Transportation Association of Nova Scotia on the practicality, cost, and fairness of mandatory sideguard protection for all contractor vehicles over a certain size. Clarke concluded the presentation by suggesting that further consultation should take place with members of the Transportation Association of Nova Scotia to better understand HRM's requirements for sideguards on contractor vehicles.

10.3.2 William H. Mahody, Q.C. Merrick, Jamieson, Sterns, Washington and Mahody, on behalf of the Nova Scotia Association of Road Builders re: Vehicle Sideguard Protection required by HRM

William H. Mahody, Q.C provided a presentation on behalf of the Nova Scotia Association of Road Builders respecting Vehicle Sideguard Protection for contractor vehicles over a certain size. Mahody expressed concerns from the membership of the Nova Scotia Road Builders Association on the practicality, cost, and fairness of mandatory sideguard protection for contractor vehicles over a certain size. Mahody concluded the presentation by suggesting that HRM and Industry representatives find a way forward to fairly implement sideguards on contracted vehicles.

In response to a question, Bruce Zvaniga, Director of Transportation of Public Works advised that a report on the progress on sideguard implementation is anticipated at Council by the summer of 2018. Zvaniga clarified the intention of staff to engage with all stakeholders on the matter including industry representatives.

The Transportation Standing Committee discussed the information report dated January 16, 2018.

In response to a question, Bruce Zvaniga, Director of Transportation and Public Works noted that the bollards installed along Rainnie Drive have improved the situation for cyclists and motorists in that area. Zvaniga advised that work is ongoing to replace broken bollards and enhance curb segments along Rainnie Drive. A permanent bike lane for the area will be implemented in 2020.

- 17. PUBLIC PARTICIPATION

Lindsay May, of Dartmouth, noted concern with respect to pedestrian safety in HRM parks, mainly in the Dartmouth Common. May noted that pedestrians have the right of way within the Dartmouth Common and that HRM has a responsibility to ensure that laws in this regard are being followed. May suggested that there should be a budget for appropriate signage and enforcement in parks to ensure pedestrian safety.

Paul Vienneau, of Halifax, recounted a personal experience of a cycling accident with a transfer truck that left Vienneau permanently disabled. Vienneau spoke in favour of sideguard protection for large vehicles contracted by HRM noting that it is a very reasonable expectation for contractors to do what they can to protect pedestrians and cyclist.

Colin May, of Dartmouth displayed photographs of the Dartmouth Common showing damage caused by cyclists in the part. May expressed concern that existing By-laws restricting the usage of bicycles in some HRM parks are not being adhered to.

Kelsey Lane, of the Halifax Cycling Coalition spoke in favour of Sideguard protection for large vehicles contracted by HRM noting that cyclist have the highest number of reported collisions with vehicles in HRM. Lane noted that the practicality of sideguards for contractor vehicles should not impact protecting the safety of residents.
