You are correct the Transportation Standing Committee is open to the public. The next meeting will take place on June 28, 2018 at 1:00 p.m. in Council Chamber, 3rd Floor City Hall, Halifax. The agenda are reports will be posted to Halifax.ca by noon on June 22.

There are two ways in which your request can be accommodated. You can make a formal request to present. If granted you will have a ten minute timeframe (maximum of two speakers) to present on a topic covered under the committee's mandate. There is also a period for questions and answers if the committee has them.
