17. PUBLIC PARTICIPATION

Murray Coolican, Williams Lake, spoke on behalf of the Williams Lake Conservation Committee and thanked Councillor Cleary for bringing forward a motion concerning the declining water levels in Williams Lake as well as staff for visiting the area residents and discussing this issue. The speaker encouraged the province to engage in reconstructing the dam and for HRM to contribute to financing the reconstruction. The speaker stated their position is not to recommend a community ownership model. The speaker spoke to issues which the speaker expressed were well addressed and others which were not effectively addressed in the report.

Margo Kerr, Williams Lake, spoke on behalf of the Williams Lake Dam Association regarding declining water levels in Williams Lake and the report before Standing Committee. The speaker stated that the impact of the leaking dam is insufficiently addressed in report, and recreational access and local beauty are underemphasized. The speaker encourage government to take action toward reconstructing the dam as soon as possible. The speaker encouraged the municipality to take a leadership role in this process.
