## 12.1.1 Bilingual Stop Signs on HRM Owned Streets

- Support Option 3, a targeted approach to replace existing stop signs with bilingual (English/French) stop signs on HRM owned streets in communities, neighbourhoods or near facilities identified by the Office of Diversity & Inclusion/ANSAIO through consultation with communities, as being established Acadian / francophone communities or are of demonstrated importance to the Acadian / francophone social, linguistic, and cultural identity; and
