- Correspondence from Martyn Williams

Martyn Williams gave a presentation and responded to questions of clarification from the Standing Committee. Williams spoke about an action plan to reduce fatal or serious injury collisions and explained how other areas within Canada approached road safety action planning. Williams asked the Standing Committee to look at the top priorities within the 2024 Road Safety Strategy. They suggested stakeholders needed to be involved in implementing the proposed action plan.

11. PUBLIC PARTICIPATION

Ben Hammer, Ecology Action Centre spoke about the Road Safety Strategy report and suggested the Municipality look at tactical infrastructure responses to rapid prototype safety for designs and better data on slip and fall injuries as part of crash response. Hammer responded to questions of clarification from the Standing Committee.

Laura White, Halifax spoke about the Road Safety Strategy report and suggested consideration be given to tracking absolute collision numbers, rather than per capita, include the size of the vehicles involved in collisions, and focus on reducing the amount of traffic on roads. White responded to questions of clarification from the Standing Committee.

Matt Stickland, District 2 spoke about the Strategic Road Safety framework and explained the benefits of installing hard bollards around crosswalks. They suggested the Standing Committee look at the Municipality's snow removal process. Stickland responded to questions of clarification from the Standing Committee.

Kendra Matis, Halifax spoke about the city's priority to transit, pedestrians, and bicyclists.

12.1 Councillor Purdy – Traffic Islands on Colby Drive

Trevor MacDonald, Solicitor and Krista Vining, Team Lead, Legislative Assistants responded to questions of clarification from the Standing Committee respecting the process to give Notice of Motion to request a staff report. It was noted that as provided for in Section 49 (1) of Administrative Order One, *Respecting the Procedures of the Council*, the Standing Committee could waive Notice of Motion on two-thirds vote.

Roddy MacIntyre, Director, Traffic Management responded to questions of clarification from the Standing Committee.

Lucas Pitts, Executive Director, Public Works spoke to the clause 27 of the AO 2021-005-OP that allowed the Traffic Authority or engineer to order the removal of any traffic calming measures if the installation of such measures resulted in an unforeseen operational or safety issue not identified through the develop of the traffic calming plan carried out under AO 2021-005-OP.
