10.2.1 Councillor Purdy

Councillor Purdy submitted a petition from residents of Colby Drive regarding the traffic islands with approximately 71 signatures requesting the removal of the traffic islands on Colby Drive.

10.3 Presentation – None

11. PUBLIC PARTICIPATION

These minutes are considered draft and will require approval by the Transportation Standing Committee at a future meeting.

Alan Borenstein, Halifax spoke about the removal of cars on Spring Garden Road to encourage more foot traffic and retail opportunities, and urged the Committee to prioritize the safety of vulnerable road users by installing sidewalks, bus lanes and bike infrastructure across the city.

Stephen MacKay, Bike Mayor of Halifax spoke about the bike lane project on Coburg Road, increased traffic in the area, and the Municipality focusing on the implementation of pedestrian infrastructure.

Dr. Magda Barnard, Halifax provided a handout to the Committee and spoke about the bike lane project on Coburg Road, urging the Committee to pause the project to reevaluate and reconsider the growth, safety and traffic impacts.

Walter Strachan, Halifax spoke about the removal of traffic islands on Colby Drive and their replacement with cheaper and safer solutions for traffic calming.

William Breckenridge, Halifax spoke about the bike lane project on Coburg Road and the need for communication with residents on the status of the project.

Ben Hammer, Ecology Action Centre spoke about the bike lane project on Coburg Road, the Municipality's commitments to HalifACT, and the Integrated Mobility and Active Transportation Priorities Plans. Hammer also spoke to Halifax Transit's budget and increased ridership. Hammer suggesting the incorporation of retirement and resignation data points and average wage per service hour in future key performance indicator reports. Hammer responded to questions of clarification from the Standing Committee.

Chris Geroux, Halifax spoke about the multi-use pathway on Coburg Road and highlighted its importance in decreased emissions in relation to HalifACT and the Integrated Mobility Plan.

Kevin Wilson, Halifax spoke in support of the active transportation project on Coburg Road and connecting the Halifax greenway and the South end of Halifax.

Talan Iscan, Halifax Cycling Coalition spoke in support of the multi-use pathway on Coburg Road and noted the lack of safe and affordable transportation options in the city.

Matt Stickland, District 2 spoke about the delay of the Spring Garden Road transit-only pilot and the Colby Drive traffic islands, suggesting the Committee amend the motion to give additional instruction to staff to investigate the redesign of the street to consider public safety first and transit first options.
